stated Mr. Levan Davitashvili, Minister of Environmental Protection and Agriculture of Georgia.

November 2, 2021 , at the World Leaders Summit , 26th Conference of Parties (COP-26), a Declaration on Forests and Land Use is being initiated by the British Government, upon which Georgia has confirmed its readiness to join the participant countries by submitting a notification.

At the plenary session, among other important issues, the importance of protecting forests in Georgia and increasing absorption of greenhouse gas emissions was stressed out by the Prime Minister of Georgia.

It is worth mentioning, that in the framework of the 26th UN Climate Change Conference of the Parties (COP26) in Glasgow, Georgia has already joined the US initiative to reduce methane emissions; as well as the initiative "Innovations to tackle climate change in agriculture."

Within the framework of the World Leaders Summit, the Deputy Minister of Environmental Protection and Agriculture of Georgia, Nino Tandilashvili


took part in the first meeting of the "High Ambition Coalition" on November 2, 2021.

On November 26, under the auspices of UNESCO, World Olive Day celebrated in Georgia



The Minister of Environmental Protection and Agriculture, Mr. Levan Davitashvili congratulated the members of the International Olive Council (IOC) on World Olive Day.

According to the Minister, Georgia has a great potential for olive production. Cultivation of olive groves will play a crucial role in the economic development of the country and will increase employment among local population.

"Georgia has immense potential in cultivation of olive trees. We are taking active measures to promote the development of the fruit industry. We have already planted intensive orchards on more than 15,000 ha of area, including

olive plantations, as part of the program "Plant the Future".

We plan to set up an olive nursery in Georgia and speed up the cultivation of olive groves by using locally produced olive seedlings. Meanwhile, the state laboratory will undertake the quality control on produced products. The state is ready to ensure co-financing to create additional enterprises in the country"said Mr. Levan Davitashvili.

In the course of the event, participants discussed challenges and opportunities of the olive sector, they also emphasized financial, economic, technological and environmental issues.

The World Olive Day was held in Georgia within the framework of the 114th session of the International Olive Council and 57th session of the Advisory Committee. The events were organized through joint efforts of the Ministry of Environmental Protection and Agriculture and the International Olive Council, under the auspices of UNESCO. Georgia joined the International Olive Council in 2019, since 2020 Georgia has been a chair country of the council.

With the support of the Ministry of Environmental Protection and Agriculture, under the auspices of UNESCO and the International Olive Council, the 114th session of the International Olive Council and the 57th session of the Advisory Committee were held in Georgia.

In the course of the sessions, the participants discussed challenges and opportunities of the olive sector.

In his speech, Minister of Environmental Protection and Agriculture, Mr. Levan Davitashvili noted, that encouraging cultivation of olive plantations in Georgia is a part of the agricultural development strategy. He also underlined, that olive crop culture has a great potential, which is resulted from Georgia's favorable climatic conditions.

"Through state support and co-financing programs, olive plantations have already been planted on up to 1000 hectares of area in Georgia. We plan to plant olive groves on several tens of thousands of hectares in the near future, which will enable us to boost our export opportunities. I believe, that active cooperation between the state and the private sector will facilitate to make the respective field more competitive in the country "Mr. Levan Davitashvili said. Giorgi Svanidze, President of the International Olive Council, Founder and President of the Olive Association in Georgia, noted that Georgia is ready to further develop olive oil production.

"We appreciate, that Georgia is a family member of the IOC. The International Oil Council is an organization that controls 90% of income derived from world olive production and 74% from trade of olive products. Therefore, being a member of this organization means to take a step forward for Georgia. Through joint efforts with the World Olive Council and the Minister of Environmental Protection and Agriculture, we have developed a strategy embracing objectives and measures on how to develop an olive sector in Georgia and enter into the global market "said Giorgi Svanidze.

Georgia has been a family member of the IOC since 2019, in 2020 Georgia became the Chair country of the council. The International Olive Council plays an important role in the development of the olive culture. The IOC organizes International forums and holds discussions to resolve any issues related to the olive sector.

Hosting the International Forum is of utmost importance for Georgia, as it is the most important global event in the olive sector. Newsletter

The forum was organized by Georgia's Foreign Trade Association within the framework of China International Import Expo in Shanghai, China.

In his welcome speech, Levan Davitashvili spoke about the importance of Georgian-Chinese relations, cross-cultural similarities and prospects for developing trade relations within the Silk Road.

The Minister stressed out the importance of viticulture and winemaking as an integral part of Georgia's history, agriculture and economy. Mr. Davitashvili stated, that Georgian wine culture is unique, and has an ancient history in the world, moreover, Georgia's unique grape varieties, as well as method of making Qvevri wine have been awarded the status of a UNESCO Intangible Cultural Heritage Site.

The Minister mentioned joint products produced by "Dugladze Wine Company" and "Fengju Group" and noted, that implementation of similar projects will boost the export of Georgian high quality wine into the People's Republic of China and will have a positive impact on Georgia's plans to deepen bilateral cooperation and friendship.

At the end of his speech, the Minister expressed gratitude to the Georgian Foreign Trade Association and the Silk Road Chamber of International Commerce .

The meeting was held in the framework of the 26th session of the Conference of the Parties (COP26) of the UN Framework Convention on Climate Change (UNFCCC)

Mrs. Tandilashvili briefed Sebastian Barkowski about ongoing projects implementing in Georgia to reduce greenhouse gases emissions and drew her attention to the international agreements signed under the Paris Agreement

In the course of the meeting, the Polish side spoke about a new initiative related to the Polish Climate Support Project, with a budget amounting to 11.25 million Euros. Respective project provides support to following areas, encompassing, development of climate policy, increasing air quality, creation of energy efficient buildings, transformation of coal-producing regions, transition to zero or low emission transport.

As part of the initiative, the Polish side will scrutinize investment, consulting, as well as different types of mixed-use projects.

At the bilateral meeting, Polish side has proposed making financial assistance for Georgian partners, if the latter agrees to cooperate with their Polish counterparts and submits climate-friendly projects.

The Deputy Minister invited representatives of the Polish Ministry to Georgia to share their experiences and deepen cooperation.

The Deputy Minister of Environmental Protection and Agriculture, Mr. Yuri Nozadze, Chairman of the Agency for Protected Areas, Mr. Davit Iosebashvili, Deputy Chairman of the Agency for Protected Areas, Mrs. Tamar Khakhishvili, Deputy Chairman of Korea National Park Service (KNPS), Mr. Song Hyung-Kun and Charge D'affaires of the Republic of Korea to Georgia, Mr. Daesoo Chang. discussed prospects for future cooperation between National Parks of Georgia and Korea.

At the end of the meeting, Chairman of the Agency for Protected Areas, Mr. Davit Iosebashvili, and Deputy Chairman of Korea National Park Service (KNPS), Mr. Song Hyung-Kun signed a Memorandum of Understanding, which envisages provision of International best practices in the management of protected areas, including protection and conservation of natural heritage.

"The Ministry of Environmental Protection and Agriculture takes efforts to integrate national parks of Georgia into the global space. We have signed a Memorandum of Understanding with the Korea National Park Service (KNPS). During the visit, the members of Korean delegation will visit unique places and see the unique nature of Georgia, they will get familiar with the biodiversity of our country, ultimately, within the future bilateral coopera-

tion, we plan to implement joint activities, regarding National Parks of Georgia and Korea "said Deputy Minister of Environmental Protection and Agriculture Mr. Yuri Nozadze.

The Memorandum of Understanding aims at fostering close cooperation through implementing joint projects. The MoU also entails provision of hands on training courses and capacity building programs for the staff of the protected areas.

"We are happy to be in Georgia and get familiar with its beautiful nature. Georgia and Korea have a similar history, culture, a unique language, a unique cultural or natural heritage that humanity must preserve.

The Memorandum of Understanding we sign today serves to explore opportunities for development by sharing management techniques or other experiences. I hope, that representatives of Georgian National Parks Administration will pay a visit to Korea and get acquainted with the beauty of our nature "said Deputy Chairman of Korea National Park Service (KNPS), Mr. Song Hyung-Kun.

It should be mentioned, that close cooperation has been established between the Agency for Protected Areas and Korea National Park Service (KNPS) over the last few years. The respective cooperation has led to the important events, namely, a joint photo-exhibition organized in national parks in Korea and Georgia, Algeti National Park.

The respective measures have laid the foundation for the two countries to promote the cooperation in the environmental protection field and take effective steps for future cooperation.

During the visit to Georgia, the members of the delegation of the Republic of Korea will pay a visit to the national parks of Kazbegi and Kolkheti, Martvili Canyon and Imereti Caves Protected Areas as well.

In the course of the meeting, the sides addressed issues of fu-


