#### Ministry of Environmental Protection and Agriculture and Swedish International Development Cooperation Agency (Sida) sign a Grant Agreement



The respective agreement will be implemented within the framework of the programme "Save the Nature - Georgia" and will support the Ministry of Environmental Protection and Agriculture in strengthening institutional capacity, improving management efficiency and promoting sustainable management of natural resources in Georgia.

As Mr. Levan Davitashvili stated, under the respective programme, the floodplain reforestation project will be prepared for the town of Rustavi.

"Krtsanisi forest-park space will be arranged in a manner, that will enable us to preserve the existing ecosystem and develop basic ecological infrastructure. The aforementioned grant agreement steps up the cooperation between the Ministry of Environmental Protection and Agriculture and the Swedish International Development Cooperation Agency, moreover, it is the first precedent of direct cooperation, thereupon, the grant agreement is particularly important for us.

It should be noted, that project is in full compliance with the priorities of Georgia in the integration process with the E U, therefore, implementation of the project will bring Georgia closer to the European Union" - said the Minister.

The program "Save the Nature - Georgia 2021-2024" has been developed by the Ministry of Environmental Protection and Agriculture on the basis of policy dialogue on thematic areas with the Embassy of Sweden. The program embraces specific actions envisaged under the strategies and action plans of the Government of Georgia in the biodiversity and air quality monitoring fields.

"The respective program will support the biodiversity protection and recovery actions. Furthermore, it will enable the Government to purchase new automated air quality monitoring stations to improve the monitoring of air quality" said Mr. Eric Illes, Head of Development Cooperation and Deputy Head of Mission at the Embassy of Sweden to Georgia.

The project will span over the years 2021-2024, with an overall budget of 56 500 000 Swedish krona.

The Ministry of Environmental Protection and Agriculture of Georgia, LEPL Agency of Protected Areas, LEPL National Environment Agency and LEPL National Wildlife Agency are direct implementers of the project.

#### Memorandum of Understanding signed on the implementation of the program "Sustainable Development of the Area of Aragvi Protected Landscape and Local Community"

The Minister of Environmental Protection and Agriculture Mr. Levan Davitashvili, Mayor of Dusheti Manana Narimanidze, Ambassador of the Czech Republic to Georgia Petr Mikyska, Ambassador of the Slovak Republic to Georgia Pavel Wizdal and the Head of the office at Austrian Development Agency Alexander Karner signed the Memorandum of Understanding.

The programme will span over the years 2018-2023, with an overall budget of 2.3 Million Euros, out of which 61% will be financed by the Czech Development Agency, 30% by the Austrian Development Agency, 9% by the Slovak Republic. On the Georgian side, the Ministry of Environmental Protection and Agriculture and Dusheti City Hall will ensure the technical and infrastructural support of the programme.

"Expansion of protected areas is our priority. The territory of protected areas has significantly expanded over the last few years, currently it makes up 12 percent of the country's territory. 100 thousand hectares have been added to the protected areas in Dusheti Municipality, part of which is represented as a protected landscape. The municipality undertakes the management of protected areas by taking into account the interests of the local community,

entailing development of local economy and traditional activities in rural areas. I firmly believe, that aforementioned support will enable Dusheti Municipality to ensure a successful management of protected areas "said Minister Davitashvili. Mayor of Dusheti Municipality, Manana Narimanidze noted, that MoU aims to improve the economic conditions and livelihoods of local communities, ensure sustainable development of tourism, agriculture, education, furthermore, it will contribute into good governance, social care services, environment-friendly management of the region, including sustainable forest management. The program intending to protect the Aragvi protected landscape meets the interests of local community.

#### The Minister of Environmental Protection and Agriculture opens the international competition "Future Agro Challenge" at the Technopark

The importance of using new technologies and innovations in the agricultural sector, as well as youth engagement and participation in the entire process was underlined by Mr. Davitashvili while delivering his opening remarks.

"The engagement of youth in the agricultural activities is one of the crucial issues. Innovation is a way to get young people interested in the agricultural sector. We have already embraced this practice, namely: there are many startups, some of them even very successful.

It's worth mentioning, that we face a worst impact of climate change. Moreover, climate change related issues were actively discussed at the 26th UN Climate Change Conference of the Parties, which was held in Glasgow, U.K, where all participant states have made obvious statements, set ambitious goals and brought forward commitments to mitigate climate change. However,

we can not reduce climate change, without introduction of modern technology and innovations, especially when we are focusing on increasing efficiency in the food sector. The agro-food sector has a crucial impact on nature and environment;

All of the aforementioned can be solved through introduction of innovations, also by conducting researches, making discoveries or adopting the accurate and precise findings. I wish you all the best of luck; We are your supporters and we must continue to work together, meanwhile, we will confirm those important findings, which will be presented and will be put into effect, as soon as they are reasonably practicable, furthermore, we would like our entrepreneurs and farmers to adopt these innovations rapidly on the one hand, and on the other hand to present them on the international arena"- said Minister Levan Davitashvili.

According to Mrs. Nino Zambakhidze, President of the Georgian Farmers' Association, modern agriculture needs state-of-the-art technologies, as well as innovative vision. Similar events will increase motivation of young people and promote their participation, which will bring a great boon to the agricultural sector.

On December 5, the national winner of the competition - "Agripreneur of the Year" - will be announced and Georgian Farmers' Association will grant the winner a cash prize of GEL 2000. The international competition "Future Agro Challenge" organized by Startup Bureau and Agro Solutions has been held for the third year in Georgia.

"The project will seek to strengthen efficiency of Parliament in the legal approximation process within the Association Agreement and increase awareness in civil society" - said Mr. Solomon Pavliashvili.

#### Presentation of the electronic timber resource management system program held in Tbilisi

The importance of introducing an electronic timber management system has been discussed at the meeting held within the project "Strengthening the Sustainable Forestry Practices in Georgia" - Implementation of Timbeter's Innovative Timber Measurement Technology".

The project was implemented by the Estonian Company "Timbeter",

through financial assistance of the Estonian Ministry of Foreign Affairs and technical support of the Georgian Environmental Organization, "Geo". Under the framework of the project, experimental activities were carried out by representatives of the Ministry, staff of the National Forest Agency and the Department of Environmental Supervision in the log sort yards and state-owned forest area.

### Carl Amirgulashvili elected as Vice-Chairman of the Bureau of Standing Committee of the Bern Convention

At the 41st session of the Standing Committee of the Bern Convention, Mr. Carl Amirgulashvili was elected as Vice-Chairman of the Bureau of Standing Committee of the Bern Convention.

The 41st meeting of the Standing Committee of the Council of Europe's Convention on the Conservation of Wildlife and Natural Habitats (Berne Convention) was held in Strasbourg, France, which lasted from 29 November to 3 December, 2021.. Within the session, Mr. Carl Amirgulashvili, Head of the Biodiversity and Forestry Department of the Ministry of Environmental Protection and Agriculture of Georgia was elected as Vice-Chairman of the Bureau for one year.

The appointment of a representative of Georgia to this position will promote active representation and positioning of our country in the structures of the Council of Europe on the one hand, and on the other hand, it will foster more effective implementation of environmental policy in Georgia.

The Berne Convention is one of the most important international treaties in the environmental protection field. The emerald network has been established and is being developed in Georgia for implementation of the Convention and fulfillment of obligations undertaken under the Association Agreement between Georgia and the European Union.

Currently, emerald network is consisted of 66 sites, while total area comprises 1,307,501 hectares. At this stage, management plans for emerald network are being developed.



It's worth mentioning, that through financial support of the German Government bilateral biogeographical seminar of the Berne Convention is planned to conduct specifically for Georgia in December 15-16, 2021, where conservation status of species and habitats protected by the Convention will be updated for each biogeographical region of Georgia.

#### Deputy Minister of Environmental Protection and Agriculture Mr. Solomon Pavliashvili met with the Deputy Head of Mission of Norway's Embassy to Georgia, Mr Marko Soldik.



In the course of the meeting, the parties discussed the resolution on plastic pollution, as one of the most pressing environmental issues, which was adopted at the UN Environmental Assembly (UNEA 5.2). This draft reso-

lution aims to establish an intergovernmental negotiating committee (INC) with a mandate to negotiate a legally binding global agreement to address plastic pollution with the objective of reducing discharge of plastics into the environment by covering all stages of the plastic life cycle and by adopting a circular economy approach to plastics.

The parties agreed to schedule a working meeting for experts of the Ministry of Environmental Protection and Agriculture of Georgia and the Norwegian Ministry of Climate and Environmental Protection. At the working meeting both sides will hold a thorough discussion upon the resolution, which will be submitted to the Environmental Assembly (UNEA), the sides will also highlight issues, regarding Georgia's Intended Nationally Determined Contribution (NDC) and it's commitments to the negotiation process # https://mepa.gov.ge/En/News/Details/20608.

#### Meeting with the representatives of the World Bank Mission

With regard to the GRAIL project, the representatives of the World Bank Mission reaffirmed their readiness to support Georgian Government's efforts in developing integrated approaches to investing in the fields of agriculture,
